**1. WORKS ELIGIBLE:** Open to all artists 18 or older. One or two works may be submitted for selection in the same media only; however, only one entry per artist may be accepted. Works only in Representational or Traditional Realism will be considered. Original oil, acrylic, watermedia, pastel and sculpture not previously exhibited with the American Artists Professional League.

**2. RESTRICTIONS:** Photo-Lithographs and Oil Pastels are not eligible. Paintings and graphics must not exceed 42" overall in either direction. This includes the frame. All work must be framed, no wrap-arounds. Sculptures must not exceed 24" at the base in either direction. Any work exceeding these dimensions will not be accepted. Living artist submissions only, please.

**3. METHOD OF SUBMISSION:** Work may be submitted by CD or Online in JPEG format, or by 35mm color slide. Sculpture, please send two views.

**CD - Digital Entry Submission:** Digital entries must be in JPEG format submitted on CD with a resolution of 300 dpi at 4" x 6". Save your image as "A" for one entry ("A" and "B" for two entries), underscore, Artist's name with last name first, underscore, and title. Example: A\_johndoe\_autumn. CD must be labeled using permanent marker indicating Artist's name (last name first), title, medium and overall dimensions including the frame (see below for details). CDs will not be returned. Include a self-addressed, stamped No. 10 business envelope for notification.

**Online Submission:** Entries may be submitted by e-mail in JPEG format with a resolution of 300 dpi at 4" x 6". AAPL Grand National Entry must appear in the subject line with the following details in the body of the e-mail: Artist's name (last name first), title, medium and overall dimensions, including frame. E-mailed work will not be processed until entry form and payment has been received. E-mail to aaplinc@gmail.com and send entry form with payment to the director of your medium. Include a self-addressed, stamped No. 10 business envelope for notification.

**Slide Entry Submission:** 35mm slides must be in standard 2" x 2" cardboard or thin plastic mounts only. No glass slides, heavy plastic mounts or oversized slides will be judged. Each slide must be labeled with Artist's name, title, medium and overall dimensions including the frame. Indicate the top and front of each slide. Slides should be sent in a plastic sleeve. Include a self-addressed, stamped No. 10 business envelope for return of slide and notification.

**4. ENTRY DEADLINE FOR SUBMISSION:** All entries must be received by Saturday, August 13, 2011. Mail all CDs or slides and other entry requirements to the Director of your Medium. Entry forms must be complete and signed.

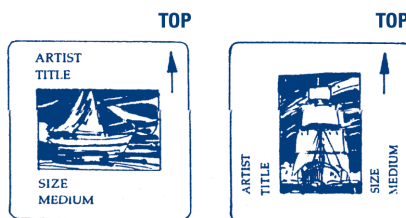

DELIVERY OF ACCEPTED WORK:** Hand-delivered work must have the Exhibition Label attached to the back and will only be accepted on Saturday, October 29, 2011, 10:00 a.m. - 3:00 p.m. at the Salmagundi Club, 47th Fifth Avenue, New York, NY. (Exhibition Label will be sent with exhibition acceptances). **POSITIVELY NO LATE ENTRIES WILL BE ACCEPTED.** Do not send crated artwork to the Salmagundi Club as it will be returned. **7. REMOVAL DATE:** All exhibited work must be picked up on Saturday, November 12, 2011 from 1:00 p.m. through 4:00 p.m. (Express Agents only: Monday, November 14) Work not called for will be subject to storage at owner's risk and will be charged a storage fee of \$10.00 per day.

**8. COLOR CATALOG:** If your work is accepted into the exhibition and you would like to have your work included in the catalog, send a CD, E-mail, or 35mm slide before September 16, 2011. Fee: \$45 made out to American Artists Professional League. Send to: Kathryn Mingo, 6 Jonathan Court, Islip Terrace, NY 11752. Include a self-addressed stamped envelope for return.

**9. LIABILITY:** The American Artists Professional League and the Salmagundi Club shall not be liable or responsible for loss or damage to artwork due to theft, fire, or other casualty or negligence. By submitting artwork to this exhibition, each artist shall be deemed to have agreed to the above agreement. Entry form must be signed for work to be reviewed.

**10. SALES:** The American Artists Professional League will make every effort to promote sales. There will be a 20% commission on all work sold.
