**1. WORKS ELIGIBLE:** One submission only by a living artist. Original oil, acrylic, watermedia, pastel, graphic and sculpture not previously exhibited with the American Artists Professional League. Only works done in **TRADITIONAL REALISM** will be considered. Photo-Lithographs and Oil Pastels are not eligible. Paintings and graphics must not exceed 42" overall in either direction. **THIS INCLUDES THE FRAME. (All work must be framed—no wrap-around.)** Sculpture must not exceed 24" at the base in either direction. **ANY WORK EXCEEDING THESE DIMENSIONS WILL NOT BE ACCEPTED.**

**2. METHOD OF SUBMISSION:** Work must be submitted by 35mm color slide only. No transparencies, CDs or e-mails will be considered. **SLIDE ENTRY SUBMISSION:** All entries must be **RECEIVED** by **Saturday, August 8th, 2009.** Mail slides and other entry requirements to the Director of your Medium. Sculpture, send two slides with two views. **NO GLASS SLIDES, HEAVY PLASTIC MOUNTS, OR OVERSIZE SLIDES WILL BE JUDGED.** Each slide must include name of artist, title, medium and overall dimensions **INCLUDING FRAME.** Indicate **TOP AND FRONT** on each slide. Poor photography may result in rejection of good work. **INCLUDE A STAMPED, SELF-ADDRESSED NO. 10 BUSINESS SIZED ENVELOPE FOR RETURN OF SLIDE. DO NOT SEND EXHIBITION LABEL FOR ACCEPTED WORK WITH CATALOG INFORMATION. ALL ENTRY SUBMISSIONS MUST BE SIGNED!**

**3. SLIDE ENTRY DEADLINE FOR SUBMISSION:** All entries must be **RECEIVED** by **Saturday, August 8, 2009.** Mail slides and other entry requirements to the Director of your Medium.

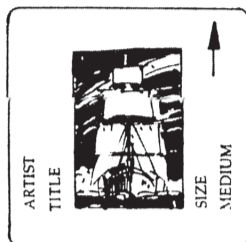
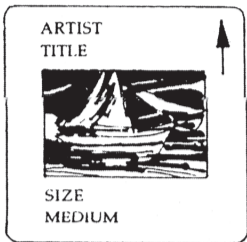

DELIVERY OF ACCEPTED WORK:** All work is to be delivered uncrated to the Salmagundi Club, 47 Fifth Avenue, NYC only on Saturday, October 31 between 1:00 p.m. and 5:00 p.m. **POSITIVELY NO LATE ENTRIES WILL BE ACCEPTED: Exhibition Label must be attached to back of work.** Out of town exhibitors may send work via agents (at your own expense) such as **DAD TRUCKING**, 855 Edgewater Road, Bronx, NY 10474, 718-893-3044, Fax 718-893-3924 or **MICHAEL DePOMPEO**, 5-00 First Street, Fair Lawn, NJ 07410, 201-873-1495. **AGENTS WILL NOT PICK UP AT AIRPORTS.** (Express Agents only: Friday, October 30.) Do not send crated artwork to the Salmagundi Club. We have no facilities for unpacking and storing crates.

**6. REMOVAL DATE:** All exhibited work must be picked up on Saturday, November 14, 2009 from 1:00 p.m. through 4:00 p.m. (Express agents only: Monday, November 16.) Work not called for will be subject to storage at owner's risk and will be charged a storage fee of \$10.00 per day.

**7. COLOR CATALOG:** Photographs of work accepted for the Exhibition will be used in the catalog. If you are accepted into the show and would like to have your work included, send a CD, 4x5 color transparency or a 35mm color slide before September 18, 2009. Fee: \$45 made out to American Artists Professional League (returned if transparency or slide is not used) and send to: Kathryn Mingo, 6 Jonathan Court, Islip Terrace, NY 11752. Send a stamped self-addressed envelope for return. **DO NOT SEND THE TRANSPARENCY/SLIDE OR FEE BEFORE YOU HAVE BEEN NOTIFIED OF YOUR ACCEPTANCE.**
